The following fees apply to a 10ft x 10ft stall space: 1 Canopy, 1-2 tables and 1 bench. **If you need additional tables the fee is \$5.00 per table upon request, only if they are available**

Saturday only \$30/day + HST (3.90) = \$33.90

Thursday only \$15/day + HST (1.95) = \$16.95

Thursday & Saturday \$30 + HST (3.90) = \$33.90

Seasonal (30 weeks, April 11<sup>th</sup> - October 31<sup>st</sup>) \$520.00 + HST (\$78.00) = \$587.60 (this saves you \$339)

Payable in 3 installments (May 1<sup>st</sup>, July 1<sup>st</sup>, Sept. 1<sup>st</sup>) \$195.86 each. Please submit all cheques at once.

Extended season (Saturday, Nov 7- Saturday, Dec. 19<sup>th</sup>) Saturdays: \$20/week + HST (2.60)= \$22.60 or all weeks for \$160.00 + HST (20.80)= \$180.80

**2 stall spaces:** \$45.00 for Saturday + HST (\$5.85) = \$50.85 no extra charge for Thursdays.

**2 stall spaces** Seasonal Rate: (30 weeks, April 11<sup>th</sup> - October 31<sup>st</sup>) \$870.00 + HST (113.10) = \$983.10 (this saves you \$542.40)

**Thursday only** vendors that are committing from May 7<sup>th</sup> to October 29<sup>th</sup>, we have a seasonal deal!

Regular rate is \$15.00 + HST per Thursday, so the whole season would cost you \$390 +HST.

New seasonal rate is \$270 + HST. So you will SAVE \$120 + HST.

The new seasonal rate total with HST is \$305.10.

You can pay for this a couple of ways:

\*1 cheque for \$305.10

\*3 cheques dated May 1<sup>st</sup>, July 1<sup>st</sup>, September 1<sup>st</sup> for \$101.70 each (that is \$90 + \$11.70 HST).

*If you choose to pay by the week, the seasonal rate does not apply.*
